





National Dental Survey: Information for parents and persons with parental responsibility



Why is there a dental survey?

Every year we collect information on the health of people's teeth. This is called a dental survey. The information helps to plan NHS dental services in your area.

This year the survey will collect information about the health of 5-year-old's teeth. You are being asked to agree to your child having a dental check (examination). This will be at their school on Tuesday 22nd March 2022.



What does the survey involve?

If you agree, your child will have a dental check by a dental team. You can come along if you like. Your child will not be forced to have a check if they do not want to. No treatment will be provided.

The check does not replace your child's regular dental appointments. You should still take your child to these.





What information will be collected?

Your child's details will be provided by their school to the dental team. These details include their name, postcode, sex, date of birth and ethnicity.

These details will be linked to your child's dental check. This will help us to understand patterns in dental health.

The information will then be sent safely to the Office for Health Improvement and Disparities.

What if the dental team finds anything wrong?



If you are there the dental team will tell you. They will also tell you what you need to do next.

If you are not there, they will give the school a letter for you.

What will the Office for Health Improvement and Disparities do with the information?



The Office for Health Improvement and Disparities works to improve health for everybody. The Department of Health and Social Care is the data controller for your child's information. The details of the children who take part will be studied and your child's dental information may be linked to other health information about them. No information will be published that identifies your child.

Information about your child is kept securely:

- in files in our offices
- on our computers

Under the General Data Protection Regulation, the lawful bases we rely on for using your child's information are:

- we have a legal obligation
- we need it to perform a public task

The information may be shared by the Office for Health Improvement and Disparities with other organisations, such as universities. Names, dates of birth and postcodes will be removed so that no child can be identified.

We keep your child's information for 3 years then we will destroy it securely.

You can ask us to delete information about your child.

You can ask us to stop processing information about your child.
